### 議員的話

為了與業界保持更密切的聯繫，我在今個立法會期開始，除了原本的年度工作報告外，增設電子通訊，每隔三至四個月向各位匯報本人的立法會工作，而今次是電子通訊的第2期。

踏入2017年，議員辦事處舉行了多個活動，題目包括啟德體育園，康文署合約及採購安排，場地伙伴計劃，「港鐵Living Art開放」等，為業界提供各項資訊。

另外，現屆政府已分別於今年1月及2月公布其任內最後一份《施政報告》及《財政預算案》，今期電子通訊撮合了內裏與業界相關的內容，以及我的一些點評，供大家參考。

隨著下一任行政長官已於三月選出，新班子的籌備工作正密鑼緊鼓地進行。我在特首選舉期間，透過不同機會，積極向各位候選人反映業界的要求，亦期望新一屆政府，必須要重視香港的體育、演藝、文化及出版的貢獻，為業界開拓更大的發揮空間，提升香港城市的軟實力。

歡迎大家繼續就本人的工作，提供寶貴意見。

特區政府分別於1月及2月發表新一份《施政報告》及《財政預算案》，與業界相關的內容摘錄如下：

The SAR government announced its 2017 Policy Address and the 2017-18 Budget in January and February respectively. My reply to the government's recommendations related to our sectors is summarized as follows:

**1 預留200億元，在未來五年增建或重建26個體育及康樂設施**

回應：歡迎，雖部分場地的興建已計劃多時，但落實有關計劃相信能在一定程度上紓緩體育界場地不足的問題。

**Inject \$20 billion in the coming five years for launching 26 projects to develop new or improve existing sports and recreation facilities**

My view:

This recommendation is welcomed. Given that some of these projects have been planned for a long time, to actually implement them could help ease the problem of insufficient sports and recreation facilities to a certain extent.

**2 改建灣仔運動場作會展用途，及其他潮玩和新穎的康樂及體育運動設施**

回應：政府在改建灣仔運動場前，必須在提出完善的替代方案，做好銜接，並與各持份者進行充分的溝通，取得共識後才展開工程。

**Rebuild the Wan Chai Sports Ground for convention and exhibition venues which comprise trendy and innovative recreation and sports facilities**

My view:

The Government must bring forward a comprehensive alternative plan for the transition, and have thorough communication with all stakeholders to reach a consensus before launching the reconstruction plan.

**3 教育局與民政事務局鼓勵公營學校進一步開放學校設施**

回應：建議回應了我曾提出的訴求，但可惜當局未有就此提出具體落實措施及內容，冀日後政府針對學校的關注，解決開放學校設施所涉的額外資源、保險及保安方面的問題。

## Encourage public sector schools to further open up their sports facilities

My view:

It is a response to my earlier calls. Unfortunately, the Government did not propose any practical measures or details of the recommendation. I do hope that the Government could pay attention to the schools' concerns, such as the problems of security and insurance, and the extra resources involved in opening up their facilities.

## 4 向「精英運動員發展基金」的注資10億元

回應：支持建議，但有鑑於體育學院支援的精英項目及在體院接受訓練的運動員數目近年日漸增加，期望注資能進一步提高，以加大對運動員的支援，以及在就學、就業、退役等方面提供更多協助。

## Inject \$1 billion into the Elite Athletes Development Fund

My view:

I support the suggestion, but in view of the number of elite sports supported by HKSI and athletes trained under HKSI have been increasing gradually in recent years, I hope that the injection could be further increased to further support athletes in schooling, employment and decommissioning.

## 5 研究進一步在本港推動電子競技

回應：政府意識到新興體育項目的發展，方向值得支持，並希望政府能更多關注其他非精英、非主流體育項目的發展，為它們提供更多支援。

## Explore further promotion of e-sports in Hong Kong

My view:

The fact that the Government is aware of the development of emerging sports is worth supporting. Besides, the Government should pay more attention to the development of non-elite and non-mainstream sports and to provide them with more support.

## 6 將原屬於政府的酒店/辦公室/住宅發展權授予西九管理局，強化其財務安排

回應：認同政府提供資源供西九持續發展，但擔心此舉會分散管理局的專注力，未能集中於推動文化藝術發展的工作。

## Enhanced financial arrangement of West Kowloon Cultural District Authority by granting it the government-owned development rights of the hotel/ office/ residential portion of WKCD

My view:

Government's intention to provide resources for the sustainable development in WKCD is recognised, but it is also worrying that the new measure could distract the WKCDA from promoting cultural and arts development.

## 7 工廈執管行動

回應：只強調執法的需要，沒有回應業界的關注及生存空間的問題，冀政府能盡快檢討現時的執管行動，給予沒有即時消防危險租戶更長的寬限期，豁免工廈業主申請將單位改作文化藝術及體育用途的短期豁免書收費，並就工廈用途的定義進行檢討。

### Risk-based enforcement actions against the misuse of industrial buildings

My view:

The Government only stressed on the need for law enforcement but did not pay attention to the concerns of the cultural and arts industry. I hope the Government can review the current enforcement actions as soon as possible, granting longer grace periods to the persons concerned in those cases of lease breaches that do not involve high risk in fire safety, and short-terms waivers to the owners who apply industrials units for cultural, arts and sports purposes. The term of "Industrial Use" for planning should be reviewed as well.

## 8 擴大培育電影業人才及推廣本地後期製作和外景協拍工作，資助和舉辦一系列活動展現本地創意產業的發展

回應：支持相關建議，但需投放更多資源，扶助創意產業內不同行業的發展；同時，政府也需為創意產業訂立長遠發展規劃，推動創意產業內不同行業，可以持續、均衡地發展。

### Nurture more film talents, promote local post-productions, location filming and production facilitation services, and subsidize activities that promote local creative industry

My view:

The government should put more resources to promote different sectors of the creative industry. At the same time, long-term planning should be formulated for promoting the industry.

## 9 投放額外資源，支持更多本地藝團和藝術家到海外及內地主要城市演出

回應：認同建議，但有關資源的投入有限，希望政府能持續加強對本地文化藝術的支持，特別是中小藝團的支援，並採取措施，提高從業員的薪酬水平。

### Inject additional resources for supporting performances of local arts groups and artists in major overseas and Mainland cities

My view:

I agree with this suggestion, but related resources are rather limited. I hope the government can strengthen its support to local cultural and arts industry continuously, especially to those small and medium arts groups, and take measures to improve the salary level of arts practitioners.

## 9 向多元卓越獎學金注資二億元

回應：相信措施能鼓勵更多學生發展他們在體育或藝術範疇的潛能，有助本地培育更多相關的人才。

## Inject \$200 million into the Multi-faceted Excellence Scholarship

My view:

The captioned measure will encourage students to develop their potential in areas other than academic performance, such as sports or arts, and thus promote the nurture of new talents.
